## ORDER:

The Renewal of Recognition order was issued vide University's Proceedings dated 27.01.2015 to the Principal, KMCH College of Pharmacy, Coimbatore for the Department of Pharmacy Practice for conducting research leading to the award of Ph.D programme for a period of one year. The said recognition was renewed for a period of three years from 27.01.2016 to 26.01.2019 vide in the reference 2<sup>nd</sup> cited.

- 2. Subsequently, the recognition was renewed for the period of three years from 27.01.2019 to 26.01.2022 vide in the reference 3rd cited.
- 3. In the reference 6th & 10th cited, the Principal, KMCH College of Pharmacy, Coimbatore, has remitted a total sum of INR.76,700/- (INR Seventy Six Thousand and Seven hundred only) i.e., INR.40,000/- towards Inspection fee, INR.25,000/- towards renewal recogniton fee and INR.11,700/- as 18% GST on Inspection fee and renewal of recognition fee for the Research Department of Pharmacy Practice.

- 4. The Inspection Commission vide in the reference 7<sup>th</sup> cited has conducted the Inspection in the Department of Pharmacy Practice, KMCH College of Pharmacy, Coimbatore, on 22.02.2022 and submitted their report on the infrastructural, teaching and other facilities in the said Research Department. The Inspection Commission has recommended for the continuance of recognition of the Department of Pharmacy Practice.
- 5. In the 48<sup>th</sup> meeting of the Standing Academic Board held on 02.07.2014, it was resolved to authorise the Vice-Chancellor to issue further Continuance of recognition of the Department.
- 6. In pursuance of the recommendations of the Inspection Commission, the Continuance of Recognition is hereby granted for the period of three years from 27.01.2022 to 26.01.2025 to the Department of Pharmacy Practice, KMCH College of Pharmacy, Coimbatore, for conducting Ph.D research programme.
- 7. The Principal, KMCH College of Pharmacy, Coimbatore, shall apply to this University <u>six months</u> prior to the expiry of the present recognition order, following the procedures mentioned in the University regulations and by remitting the prescribed inspection fee and Recognition fee for the grant of the Continuance of Recognition of the above said department for the purpose of Ph.D Programme.
